# Overseas Licence Policy Change

Communication Toolkit for Stakeholders – Version 2 December 2023







## Key messages Overseas Licence Policy Change

- Two core changes that impact overseas drivers were introduced to the <u>Road Transport (Driver Licensing) Regulation 2017</u> on **1 July** 2023.
- The first change is a **six-month residency rule** whereby temporary visa holders who intend to reside continuously within NSW for six months or longer will need to convert to a NSW licence *within* six months if they wish to continue to drive.
- The second change is a **withdrawal of driving privileges**. The regulation now allows for overseas drivers to be stripped of their driving privileges permanently if they accrue 13 demerit points or are convicted of certain speeding, drug and alcohol or serious driving offences. If these overseas licence holders wish to drive again in NSW, they will be required to obtain a NSW driver licence once they have completed their suspension or disqualification period (whatever is applicable). They will not be permitted to drive again in NSW using their overseas licence.
- We all have a role to play when it comes to road safety. This policy change provides an important opportunity for overseas licence holders to learn more about the NSW road transport system.
- Tragically, since the beginning of 2023, there have been five fatal crashes involving a driver or rider with an overseas licence.
- By completing theory and driving tests, overseas drivers can gain the important skills and knowledge they need to be safe on NSW roads and help to reduce the rate of road trauma.

## Key messages Overseas Licence Policy Change

- Thank you to the 20,000+ temporary visa holders who have converted their overseas driver licence to a NSW driver licence since 1 July 2023.
- Have you arrived on a temporary visa from 1 July 2023 and yet to convert your driver licence? Don't delay head to a Service NSW Service Centre to convert your licence today.
- If you do not convert your overseas licence within 6 months and you continue to drive in NSW, then you will be deemed unlicenced by the NSW Police.
- Make sure you leave enough time to obtain your overseas licence. Depending on the country you received your driver licence, you may need to pass the <u>Driver Knowledge Test</u>, <u>Hazard Perception Test</u> and <u>The Driving Test</u> to obtain a NSW driver licence.
- Driving whilst unlicensed will incur a significant fine and may impact insurance coverage on your vehicle or motorbike, especially in an accident.
- The NSW Police can impound vehicles and confiscate number plates from drivers who continue to drive unlicensed or disqualified.

- To support the increased demand for testing for licence conversion, a new Service NSW Driver Testing Centre (with only Driver Testing services available) is now open at the Macquarie Fields Tafe building.
- The Service NSW Macquarie Fields Driver Testing Centre opened for bookings on December 8 and will offer around 300 driving tests a week, especially to help overseas licence holders convert to a NSW driver's licence.


Make sure you leave enough time to obtain your overseas licence. Depending on the country you received your driver licence, you may need to pass the <u>Driver</u> <u>Knowledge Test</u>, <u>Hazard Perception Test</u> and <u>The Driving Test</u> to obtain a NSW driver licence.

## Overseas licence holders converting to NSW system

Almost 20,000 drivers on overseas licences have converted to a NSW licence over the past 4 months, with some taken off the road altogether after running up enough demerit points to lose a licence almost 3 times over.

The Minns Labor government has welcomed the first tranche of foreign licence holders rolling over to a NSW licence but is determined to go further than the previous Coalition government, with all drivers on overseas licences in future to be directed to convert their licence.

Under the current regulation brought in by the Liberals, only drivers moving to NSW since 1 July 2023 must convert to a NSW licence.

This has led to 20,000 foreign licence surrenders since that date.

The regulation now allows for overseas drivers to be stripped of their driving privileges permanently if they accrue 13 demerit points or are convicted of certain speeding, drug and alcohol or serious driving offences.

## Service NSW ready to help overseas drivers get a NSW licence

Temporary visa holders who arrive on or after 1 July and who intend to live in NSW for more than six months are encouraged to plan ahead and convert their licence as soon as possible so they can continue to drive with confidence.

The new regulation changes are designed to give confidence to all road users and ensure all motorists understand the State's road rules and abide by the same standards, with any temporary visa holder required to convert their licence within six months.

The process for converting to a NSW licence will differ depending on the age of the applicant and the country where their licence was issued.

Overseas licence holders from certain recognised countries with similar licence systems to Australia (such as the United Kingdom, Germany and Singapore) as well as experienced drivers aged 25 or older from other recognised countries (including Poland and South Korea) can visit any Service NSW Service Centre to convert their licence without the need to sit a knowledge test or a driving test.

All other overseas licence holders will be required to pass a knowledge test and driving test at a Service Centre to receive a NSW licence. They will be exempt from the learner driver logbook requirement.

While the former government originally announced the new rules would require all overseas licence holders to apply for a NSW driver licence within six months, they backtracked in December 2022 to only apply the change to temporary visa holders arriving from 1 July 2023. The Government is examining these issues.





**Overseas driver licence** holders' new arrangements from 1 July 2023

## NSW

There are two new measures that will apply to overseas licence holders on temporary visas from 1 July 2023 the 'six-month rule' and 'withdrawal of driving privileges'.

#### Six-month rule

Transport for NSW - nsw.gov.au

The new arrangements apply to a person who takes up residence in NSW on a temporary visa on or after 1 July 2023.

Under the new arrangements, temporary visa holders will need to obtain a NSW driver licence within six months if they have resided continuously in NSW and wish to continue to drive.

To be a resident of NSW a person must ordinarily live at an address that is in NSW. A person may visit another state temporarily for a holiday or for work but would be considered to be continuously living in NSW. The timeline driver licence by 1 January 2024. starts from the date that a person obtains, changes to. or uses a NSW address as their primary location. Example 3

Overseas licence holders who are residents of NSW prior to 1 July 2023 can continue to drive on their overseas licence and would not be required to meet the new requirements



Person B arrives in NSW on 1 July 2023. Person B will reside continuously in NSW for six months or more from that date. Person B would be required to obtain a NSW

Person C resides in NSW for five months and then goes to Queensland for a one-month holiday. Person C is still required to obtain a NSW driver licence as their main



#### Withdrawal of visiting driver privileges

On 1 July 2023, new arrangements will start for all persons in NSW driving on an overseas driver licence. Transport for NSW will permanently withdraw a person's visiting driver privileges if they:

- accrue 13 demerit points; or · are convicted of a serious driving offence (listed under section 224 of the Road Transport Act 2013), or
- · are suspended or disqualified from driving a motor vehicle in any part of Australia or another country; or
- are convicted of a drug or alcohol-related driving offence.

#### Serious driving offences include the following:

- · drive in a manner that causes a serious accident, causing death or grievous bodily harm
- · speed in excess of 45 km/h over the speed limit
- speed in excess of 30 km/h over the speed limit
- drive with a prescribed concentration of alcoho
- or prescribed illicit drug present · take part in street racing and other hoon
- · drive without supervision (learner licence holders)

Overseas Driver Licence Policy Change

Getting your NSW driver's licence

Read the Road User Handbook to familiarise yourself with the NSW road rules to ensure you drive safely on NSW roads.

Complete your licence application form and prepare your supporting documentation.

Take your application form and required documents to a Service NSW Service Centre including proof of identity, your current overseas licence and translated documents if they're not written in English.

You will be advised at a Service NSW Service Centre if you meet licence eligibility, and if you are required to complete the Driver Knowledge Test and Practical Road Driving Test.

Applicants should allow plenty of time to meet all requirements for a NSW driver licence and successfully obtain, not just apply for, a NSW driver licence well before the end of the six-month period.

#### Penalties

From 1 July 2023, penalties will apply to a temporary visa holder who has resided in NSW for a continuous period of six months or more, and who continues to drive in NSW on their overseas licence. They will be considered to be driving a vehicle unlicenced.

> It is proposed that a fine of \$603 will apply for a first offence and a fine of \$924 will apply for a second or subsequent offence. A maximum penalty of \$2200 (20 penalty units) may be imposed by a court.
